Mr. Boyer reviewed the student activity balance.

Mr. Boyer reviewed the Food Service Financial and noted in FY 2020/2021 there were 57,000 meals served and this year there were 77,000 meals served. He noted it has been a very productive year with the meals served. In the food department they cannot have more than 3 months of expenses. Mr. Boyer advised the Food Service Department is doing meal delivery and summer school. They are serving about 70 meals each day. Today was the last day of summer school and the last day of meal delivery will be June 30th.

Mrs. McCauley said summer school was concluded today. She noted there were approximately 40 students that attended the 4 week program. Mrs. McCauley advised the

High School used the online Edgenuity program for credit recovery. Not everyone that needed to attend summer school for the high school attended. Mrs. McCauley advised that Gerri Chasko brought spaghetti lunch yesterday and rotary served it. She commended the Summer School staff.

Mrs. McCauley said preparations are under way for the next school year. She said she is closing out this school year with some of the state reports, integrated action plan to the state, and combined plans into the LEA integrated action plan. She said she is also working on our own school data for school improvement. Also college and career and readiness index is due the end of this month.

Mrs. McCauley said we just finished our summer hiring for the school year and thanked Mrs. Goessman for her help. She noted the high school is now fully staffed. For elementary we did find an office manager, teacher, para, and preschool para. We will have the training for the new employees the day before the rest of the teachers.
